# 1. EXECUTIVE SUMMARY

## 1.1 INTRODUCTION

*The year 1993-94 brought a new light in the history of Higher Education in the Tribal populated Khunta Block in the District of Mayurbhanj. In this year some intellectuals immensely felt the necessity of establishing a Degree College in this Tribal Area to promote Higher Education. However, the college took birth at Khunta High School's vocational building on 6th September 1993 by the permission of Govt. Of Odisha with 64 seats in Arts stream. It is the first and only Degree College of this Block. In the year 2003-04 the seats of this college increased from 64 to 96 and later it increased up to 128 and finally 128 to 196 by the year 2015-16. In addition to this Science Stream was also opened in the year 2016-17 with 64 seats, later it is increased up to 96 seats with Honors*

*The department of Higher Education Odisha, Utkal University and North Odisha University have granted recognition / affiliation to this institution permanently. The college has owned land at remote place for which diversion to the present location is being made.*

*The Institution got permanent recognition / affiliation to a limited seat and has been included 2 and 12b under UGC during the year 2011-12. For last 25 years the college has been marching towards the fulfilment of aims and aspiration of the institution basically the spread of Higher Education among the Tribal populated locality.*

### **Curricular Aspects**

**The Institution imparts its teaching practices in a systematic Mastertimetable framework starting from 10.00 A.M to 05.00 P.M as per the distribution of CBCS Semester Pattern. Seven (06) Hons. Subjects like Economics, Education, History, Odia, Political Science, Sanskrit & Generic Elective Subject & (05) Hons. Subjects like Botany, Chemistry Mathematics, Physics & Zoology along with AECC Course like Environmental Science & Communicative MIL(Odia, Alt. Eng & Santali), SEC Course like Communicative English & Quantitative Aptitude & Logical Reasoning & DSE Courses in each Honours Subjects are taught by Lecturers keeping in view the larger interest of the students. Time to Time surprise tests, Midterm Examination are undertaken by the departmental teachers to measure the level of understanding of the students. Subjects having Practical, the Practical Examinations also are held from time to time by the concerned subject teachers. The teachers maintain their plan and progress registers in which they record their daily teaching practices.**

### **Teaching-learning and Evaluation**

We not only transform a students with their academic development but always rigorously extend our service with co-curricular, extracurricular & extension activities. Moreover, students have been taught to access the latest ICT. Even experienced teachers have been appointed to boost the technical access of the students. Special timetable has been fixed for the learners inside the college campus, even a few staff members are also learning in this process.**

### **Research, Innovations and Extension**

The College have NSS, YRC and different social and cultural units to organize different State and National Level Programme to build a social consciousness among the students. All the Extension activities and outreach programmes has been organized under the sponsorship of IQAC. The college has never stop its extension activities as post Accreditation initiatives. *The College have NSS, YRC and different social and cultural units to organize different State and National Level Programme to build a social consciousness among the students. Students have also attended National Level participation in NSS & YRC. Different awareness programme such as Swatch Bharat Abhiyan, Beti Bachao Beti Padhao, Van Mahotsov, Road Safety, Save Similipal Awareness Campaign are the achievements. Students have achieved and received many Certificate and awards by organising activities. Special camp by NSS for atleast seven days are organized as the collaborative scheme. The villages have been adopted by our NSS for the only purpose to solve the most urgent requirement of the village. Mask , Sanitizer distribution and a vaccination camp in college campus was the appreciative work during covid-19 pandemic. Free eye checkup and cataract surgery camp and special orientation programme on tobacco free educational institution had been organized. Awareness programme like gender sensitization/ Equity, use of sanitary napkins for girls students has been conducted in our institution. A free sanitary napkin distribution drive was also made by IQAC in collaboration with NSS and YRC in college campus, ST Girls hostel & also a near by village.*

### **Infrastructure and Learning Resources**

The Institution ensures adequate availability and optimal utilization of physical infrastructure as it is critically linked to the vision of the college through technologically advanced pedagogical tools. At the beginning of the academic session need assessment for replacement/ up gradation/addition of existing infrastructure is carried out based on the suggestions from G.B members, Head of the Departments, Administrative and Academic Bursars after reviewing course requirements, budget constraints, human resources availability and also student grievances. The Time Table committee plans ahead for the requirements regarding classrooms, furniture and other requirements. Optimal deployment of infrastructure through conducting awareness programs, seminars, meetings, co-curricular activities, examinations, etc. There are 18 numbers of classrooms and 11 Departmental rooms which are well equipped with benches, blackboards and whiteboards. 04 room well equipped with smart board. Other 07 class rooms are fitted with LCD & Computers. There is also a Conference hall to equip 128 students with projector and public address system. The Computer center provides desktop computers, CD writers, laptops, etc. The library is partially automated with E-Library facilities. The college provides residential accommodation to 227 girl students in its two women's hostels (ST/SC Girls Hostel & Gangahar Womens Hostel) and 200 boys in its one boy's hostel (ST/Sc Boys Hostel). A Basket ball court is also well prepared for students in college campus.

### **Student Support and Progression**

Besides that the various wings like NSS, YRC are doing their jobs for social upliftment by their awareness camps. Every year NSS volunteers organize special camp at various villages of Khunta and nearby area. The volunteers take active part in camps to eradicate the social evils like Superstition, Dowry and Child Marriage. They also take active participation for the Sanitization, Adult Education. So far as NSS & YRC cadets, the cadets give emphasis on discipline, motivate the students for leadership qualities and adventures works. They celebrate various days like World Yoga Day on 21st June of every year, Independence Day, Republic Day, Gandhi Jayanti in their curriculum. They take active part in Republic Day parade and disaster management. In various occasions the cadets help the local

administration for maintaining peace and order. Again in the field of medical services YRC wing of our college plays a pivotal role. Because every year YRC units of our college organizes Mega Blood Donation camp. In that camp more than 200 units of blood are collected from our college students and staff members. Beside that an awareness camp on World Aids Day on 1st December every year is organized by our YRC wing. Every year our college organizes Athletic Meet and Annual Function by the active participation of Student. In that function, the Champion of Athletics Meet and the best Dramatic is felicitated by the inviting Chief Guest. College has transparent mechanism for timely redressal. Anti Sexual Harassment & Anti Ragging Cell have been formed to provide safety for moral support for the students.

A unique event called BANAMAHOTSAV is being conducted every year to promote Indian culture & heritage.

College has registered Alumni Association who taking part in financial/ Non-Financial contribution for the student's welfare & College Development.

Quality Teaching at Khunta Degree Mahavidyalaya, Khunta, Mayurbhanj, Odisha involves several dimensions, including the effective design of curriculum and course content, a variety of learning contexts (including guided independent study, project-based learning, collaborative learning, experimentation, etc.), soliciting and using feedback, and effective assessment of learning outcomes. Subjects, Generic Elective along with AECC Course & Communicative MIL, Ethics & Value was introduced as Compulsory subject & SEC Course & DSE Courses in each Honours subjects are taught by professors. Surprise tests are undertaken by the departmental teachers to measure the level of understanding of the students. The teachers maintain their lesson plans and progress registers.

Regarding 'CIE' the Institution conducts mid-semester examination for all subjects. The marks and exact dates of these mid-semester exams are notified by the Controller of Examinations in due time.

- There will be no mid semester examination for Language and Environmental studies courses.
- The marks, method and date of such Internal Assessments intimated to the students by the concerned Head of the Departments.
- Weightage of Mid semester exam and of Continuous Internal Assessment (CIA) added to the Endsemester Exam. This weightage will be notified by the Controller of Examinations to the students in Every Semester separately.
- All students must note that attendance in any type of Assessments (Mid semester and/ or CIA) is compulsory. The absence or non participation in any such Assessment will imply that the concerned student has secured zero in that assessment. Every examination conducted as per the academic Calendar.

The Institution imparts its academic activities as per the prescribed syllabus by the University. The College has received Permanent Recognition and Affiliation From the Govt. of Odisha and the Maharaja Sriram Chandra Bhanja Deo University simultaneously. The Time Table committee plans ahead for the requirements regarding classrooms, furniture and other requirements. Optimal deployment of infrastructure is done through workshops, awareness programs, seminars, meetings, co-curricular activities, examinations, etc.

There are 15 numbers of classrooms, 06 numbers of Laboratory and 05 Departmental rooms which are well equipped with benches, blackboard and whiteboard, Podium etc. Four classroom has been well equipped with smart boards. All Laboratories are fitted with LCDs & Computers. There is also a seminar hall to accommodate 128 students with projector and public address system.

The Computer center provides desktop computers, printers, CD writers, laptops, scanners, etc.

The library is partially automated with reprography facilities.

The college provides residential accommodation to 227 girl students in its two women's hostels (ST/SC Girls Hostel & Gangahar Women's Hostel) and 200 boys in its one boy's hostel (ST/SC Boys Hostel)

The library consists of 12309 number of books comprising of all branches of social and physical sciences, language and literary books in English, Sanskrit and Odia. It uses specialized integrated library automation system that is Ezy Vidyarthi, Library Automation System Version 1.0.5 powered by the Infocreatives.**

**To meet the growing needs of students and maintaining academic integrity in the college, various steps were taken by the Library during the last few years. Barcoding of the books has been maintained since 2021. It helps the Librarian to maintain the database of new books and the books borrowed by the members along with their due dates. Enhanced storage techniques are used to store the books in shelves. Each book shelf has been provided with a unique number to locate them**

separately. Whenever a user asks for a book, the Librarian searches for the book in the database and locate the exact shelf number. Various searching methodologies have been used to locate a particular book. Books can be searched by using the title, author, publisher, supplier purchase date, year, source or barcode. Books are issued and returned using the barcode. Even the syllabus and previous years' question papers have been supplied by the librarian. The purpose of library management system is to provide instant and accurate data. Thus, it saves much time and effort.

The same infrastructure supports approximately 1000 number of users to access the network simultaneously. The new access points are good, cheaper, have cloud-based management and do not need license. The Server which is connected to the Router is controlled by the college to impose restriction on browsing any illegal contents by members. The network is monitored by the college on regular interval. The institution also provides Wi-Fi network inside the classroom, and computers are installed in various departments. Wireless LAN credentials are enforced to access the Wi-Fi network by the server.

The institute has formulated certain policies. Computer and IT facilities have also been provided to different departments. The individual or the department shall be responsible to report any hardware or software related faults to the authority. The authority shall take all necessary steps to resolve the issue at the earliest. However, faults that require substantial additional financial expense may be given by the concerned Department.

If a gross violation has occurred, the authority will take immediate appropriate action. Such action may result in closing of internet and/or email privileges, severe reprimand and/or disciplinary action. The user's computing and network access may be suspended.

The monetary resources include cash resources like tuition fees, membership fees and grants of government, the non- monetary resources include all the available human resources in the college and from outside, like Researchers, Examiners from the University, the Governing Body, volunteers etc. and logistics (vehicles, computers, buildings, etc.), There are some other resources like technical assistance, study, training, counselling, mediation, study tours, coaching, transportation, publishing, etc. Money is one of the key resources that all organizations need to operate and carry out their activities. **Yoga Programme:**

**The college wants its students to be aware of the advantages of yoga practice and encourage healthy living. The organisation holds that yoga has mental as well as physical healing properties.**

**Certain obstacles had to be overcome by the students, the mentors, and the trainer in order to develop and execute the practice. It was challenging to persuade additional pupils to sign up for yoga classes. Since many of the institute's students are from far-off places, it is not practicable for them to travel to the college to receive yoga instruction from a qualified instructor. They were undoubtedly encouraged to practise yoga at home, but the benefits of receiving professional instruction are long-lasting. Consistency was one of the challenges that the students as well as the mentors had to face because some students got tired, lazy or unmotivated after few days of practice, and it was challenging for the mentors to encourage and motivate them to continue with the practice as it will be beneficial to them in the long run. The trainers, the mentors and the students tried their best to overcome any hurdles that came their way and continue to make Yoga as a successful practice in the college.**

**Computer Programme:**

**The college's computer certificate program seeks to teach students a variety of computer-related skills that they will need to improve their performance and better grasp the various functions of computers. Additionally, it will assist students in pursuing post-secondary education, research, and development, and it will raise their awareness of the potential and constraints of computers. The course was designed by experts in the field in such a manner that it covers from basic computer operation knowledge to using computer applications, like Microsoft office. The course included C programming as well.**

**Experts created the course, which was thoroughly distributed to students so that those who were interested knew what they were getting into. After the students went through the admission**



process, forty hours of classes were taken. After the completion of the course, the students had to give an examination and if, any student was found having any problem in understanding anything related to the course, doubt clearing classes were provided. Moreover, after the end of the program, the students are given certificates which give them certification to perform specific tasks on the computer.

Under the certificate program of the college, students are trained to use Microsoft paint, edit texts in Microsoft notepad, use Microsoft office and c programming language. The course had its limitations. As the students of the institution were not very acquainted with the basics so, it was not possible to include much advanced level course for the computer certificate program. Due to financial constraints, the college was unable to provide enough desktop computers for every student. However, even though they had to share a computer with two of their peers, every student was given the chance to complete the practical independently. The college made an effort to set up every resource needed for the course.

The course of study of different departments in the college has gender related papers which helps the students to understand gender related issues even better.**

**Moreover, the college observes International Women's Day every year on March 8 and supports the LGBT community by educating its students about it. The Principal as well as the staff members together try to sensitize the students as much as possible on gender related issues and make them understand that gender is not something which can be enforced on individuals, rather it should be accepted by persons with an open heart and happiness.**

**Majority of the times, the issues surrounding girls and women gets acknowledged but, boys and men are left unheard. The college believes that even its male students undergo various problems, be it physical or psychological, and the staff members make sure that they are open to understanding the issues faced by the male students of the college and tries to sort it out.**

**There are women's common rooms where sanitary pads are available. The college has cells for the safety, security and counselling of both male and female students. Self defense classes were given to female students. Self defence programme had been organised from the session 2014-15 to 2019-20 according to the guideline of Higher Education Department, Govt. Of Odisha. The students are made well aware of the various laws protecting their rights and wellbeing.**

**The students are also sensitized about the LGBT community through curricular and co-curricular activities, like through various competitions with topics related to it and talks given on the topic. Even in classroom teaching, the lecturers of the college make sure that they instill in the students' minds that people have the right to choose their gender and every individual deserves equal opportunities and respect, irrespective of what gender it chooses for itself. It may not be possible for the college to change the mindset of all those people who view gender with a narrow mindset but, the few thousand students that takes admission every year are sensitized with a hope that they will view gender in a positive light and pass it on to other people and to their next generation so that they get to see a world where people belonging to any gender can live freely in the society with**

the respect that they deserve.

**2. OBJECTIVES OF THE PRACTICE :**

**THE COMPUTER CERTIFICATE PROGRAM IMPLEMENTED BY THE COLLEGE AIMS AT TRAINING THE STUDENTS AT VARIOUS SKILLS RELATED TO COMPUTER.**

**3. THE CONTEXT :**

**THE COLLEGE BEING LOCATED AT A RURAL AREA, WHICH IS NOT VERY ADVANCED AT COMPUTER SKILLS AND APPLICATION DUE TO LACK OF PERSONAL COMPUTERS AT HOMES, THE STUDENTS HAD TO FACE MANY CHALLENGES WHEN IT COMES TO USING ONE. THERE WAS LOW LEVEL OF ACCESSIBILITY. HENCE, THE COLLEGE DECIDED TO BEGIN A COMPUTER CERTIFICATE PROGRAM FOR ITS STUDENTS SO AS TO MAKE THEM WELL ACQUAINTED WITH COMPUTER APPLICATION AND TRAIN THEM TO FACE CHALLENGES RELATED TO IT. THE COURSE WAS DESIGNED BY EXPERTS IN THE FIELD IN SUCH A MANNER THAT IT COVERS FROM BASIC COMPUTER OPERATION KNOWLEDGE TO USING COMPUTER APPLICATIONS, LIKE MICROSOFT OFFICE. THE COURSE INCLUDED C PROGRAMMING AS WELL.**

#### **4. THE PRACTICE :**

**THE COURSE WAS DESIGNED BY EXPERTS AND IT WAS CIRCULATED AMONGST THE STUDENTS IN DETAIL SO THAT THOSE INTERESTED KNEW WHAT THEY WERE SIGNING UP FOR. AFTER THE STUDENTS WENT THROUGH THE ADMISSION PROCESS, THEY WERE GIVEN THEORY AS WELL AS PRACTICAL CLASSES. FORTY HOURS OF CLASSES WERE TAKEN. AFTER THE COMPLETION OF THE COURSE, THE STUDENTS HAD TO GIVE AN EXAMINATION COVERING THE SYLLABUS IN THE PROGRAM SO AS TO ASSESS STUDENTS' PROGRESS AND IF, ANY STUDENT WAS FOUND HAVING ANY PROBLEM IN UNDERSTANDING ANYTHING RELATED TO THE COURSE, DOUBT CLEARING CLASSES WERE PROVIDED.**

**AFTER THE END OF THE PROGRAM, THE STUDENTS ARE GIVEN CERTIFICATES WHICH GIVES THEM CERTIFICATION TO PERFORM SPECIFIC TASKS ON THE COMPUTER. UNDER THE CERTIFICATE PROGRAM OF THE COLLEGE, STUDENTS**

**THE COURSE HAD ITS LIMITATIONS. AS THE STUDENTS OF THE INSTITUTION WERE NOT VERY ACQUAINTED WITH THE BASICS SO, IT WAS NOT POSSIBLE TO INCLUDE MUCH ADVANCED LEVEL COURSE FOR THE COMPUTER CERTIFICATE PROGRAM. THE COLLEGE LACKED IN FUND TO AFFORD MORE NUMBER OF COMPUTERS FOR THE REGISTERED STUDENTS TO GET THEMSELVES DO THE PRACTICAL INDIVIDUALLY. BUT, THE COLLEGE TRIED THEIR LEVEL BEST TO SORT OUT THE HINDRANCES THAT CAME ITS WAY AND DID EVERYTHING POSSIBLE TO MAKE THE PRACTICE BENEFICIAL TO THE STUDENTS.**

#### **5. EVIDENCE OF SUCCESS :**

**THE COLLEGE PLANNED TO PROVIDE 40 HOURS OF COMPUTER TRAINING CLASSES TO THE STUDENTS AND IT WAS SUCCESSFULLY COMPLETED. TESTS WERE CONDUCTED TO EVALUATE THE LEVEL OF UNDERSTANDING OF THE STUDENTS AND IF ANY STUDENTS IS FOUND LAGGING BEHIND, IT WAS MADE SURE THAT ITS DOUBTS WERE CLEARED.**
