### Important notice for the applicants seeking admission into U.G. Courses under SAMS for Academic Session-2025-2026

Revised timeline for e-Admission in all Universities (imparting U.G. Courses)/ (+3) Degree Colleges including Self Financing (Degree) Colleges/ Sanskrit (Shastri) of the State under Student Academic Management System (SAMS) is given below. Any changes in the timeline will be published in the newspapers as well as on the website [www.samsodisha.gov.in](http://www.samsodisha.gov.in). Kindly refer to the Common Prospectus (CP) before filling up the CAF. The key points of U.G. e-admission for the academic session 2025-26 is as follows:

- ❖ The Government of Odisha has approved the implementation of **11.25% reservation for candidates belonging to the Socially and Educationally Backward Classes (SEBC) in admissions to Undergraduate (U.G.) courses** in Higher Education Institutions (HEIs) under the administrative control of the Higher Education Department, starting from the academic year 2025-26.
- ❖ Accordingly, applicants belonging to the SEBC category are advised to obtain a valid SEBC certificate from the competent authority and keep it ready for submission during the admission process.
- ❖ **As per the directive of the NCTE, New Delhi, admissions into the Four-Years Integrated B.A. B.Ed. / B.Sc. B.Ed. programme will be permitted for the academic session 2025-26 in all previously participating Higher Education Institutions (HEIs), except Maharaja Purna Chandra Autonomous College, Baripada. Accordingly, applicants who have submitted their CAF earlier, may select these programs during the CAF editing period.**
- ❖ Applicants who had selected the "Appeared" option and submitted the CAF, can now update their +2/equivalent marks within the timeline mentioned below. For CHSE students, the marks will be directly displayed in the CAF as per the CHSE result database. However, the applicants from other Boards have to enter their marks in the designated fields within the specified timeline.
- ❖ Applicants may edit their CAF multiple times within the specified timeline to address any discrepancies. However, they must retain the latest printed version of the CAF and present it during the admission process.
- ❖ In line with NEP-2020 structure, during filling up the Common Application Form (CAF), applicants can choose their course type based on availability at their preferred institutions: (i) Single Major with two Minors, (ii) Double Major, or (iii) Three Minors. However, the selection will be done only for the Major-I subjects based on the applicants' preferred choices.
- ❖ The seat allotment will be made as per the opted Major in Single Major, Major-I in Double Major and General in Three Minors. Apart from this, all other subjects will be mapped based on the request made by the Student and counselling process at HEI Level.


